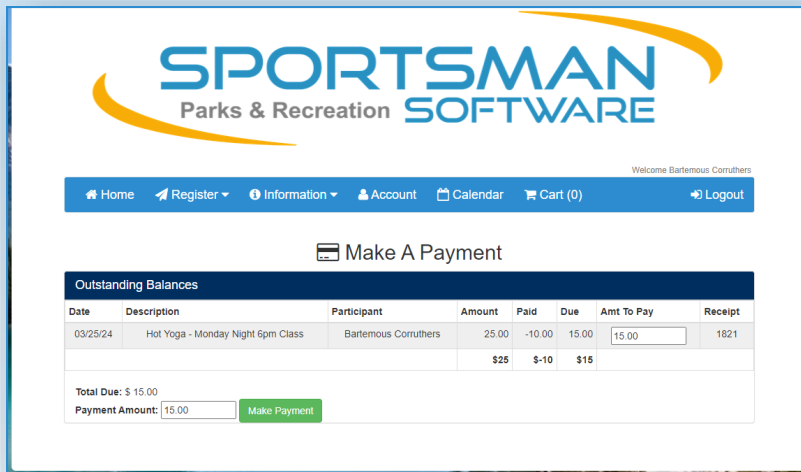
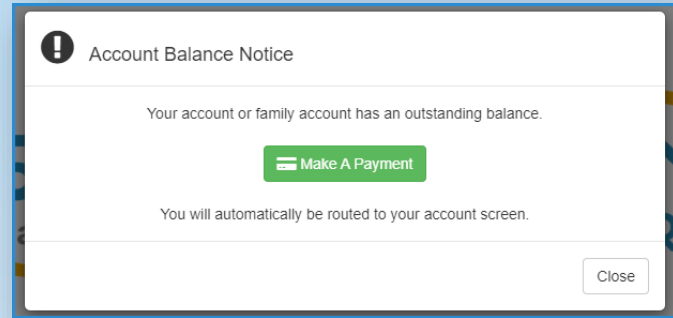

Sportsman has always been driven by the needs of our customers, and we love the opportunity to hear, directly from you, what will have the most impact for your organizations. The first feature to be voted to the top and developed based on the request board is the ActivityReg prompt for payment of outstanding balances.

When a patron with an outstanding account balance logs into their account on your ActivityReg site, they will be prompted to make a payment and automatically directed to their account screen. We know you have things you'd rather spend your time on than chasing down account balances, and giving your patrons a reminder and a convenient way to pay will be a great way to clear those up.

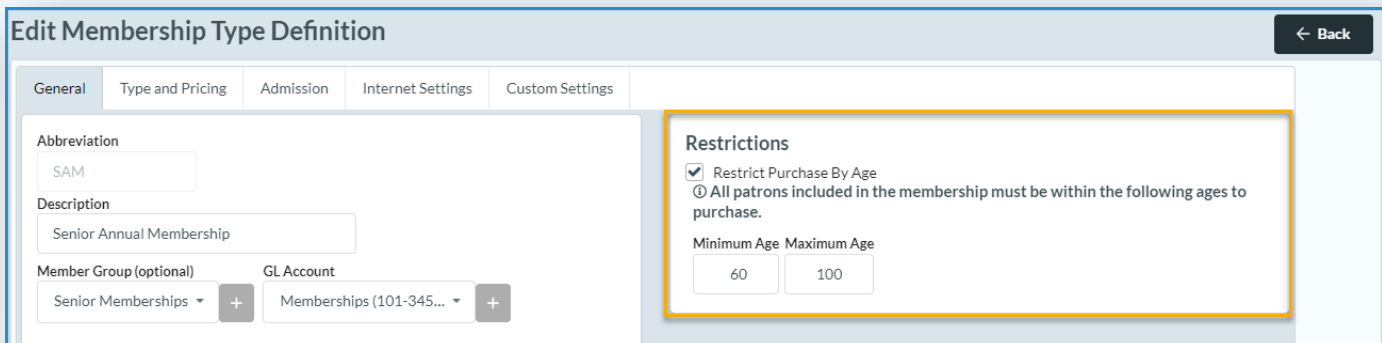

Age Restriction for Membership Sales

Another client-driven enhancement to Sportsman added this quarter is the ability to restrict membership sales based on age. Configuration is simple, just check the box to Restrict Purchase by Age, and set the age parameters you'd like to associate with the membership. Any patron included in the membership sale will be required to fall within the set ages to qualify.



Electronic Waiver Agreement

Another request to be completed from the Feature Request Board is the Electronic Waiver Agreement for in-house and over-the phone registrations. You asked for a convenient and foolproof way to collect waivers from your patrons for registrations not completed online, and the Sportsman Web development team delivered.

You no longer have to print, collect signature, scan, and upload a waiver to a patron's profile. Once enabled, Sportsman will prompt you during the registration process to verify a valid cell phone number is entered for the patron, then send the waiver agreement via text.

The patron will click the link in their text to be directed to the waiver agreement. Sportsman will show the waiver status, in real time, moving from incomplete, to waiting for agreement, then to complete and allow you to move forward with the registration.

The Electronic Waiver Agreement feature is exclusively available in Sportsman Web, and once enabled, you will be required to complete any in-house registrations using Sportsman Web. (Which is pretty perfect, since that's where all the good stuff is anyway!)
